WHOLE SCHOOL ATTENDANCE POLICY



Three Rivers Federation Schools is committed to providing a full and efficient education to all pupils and embraces the concept of equal opportunities for all.

We will endeavor to provide an environment where all pupils feel valued and welcome.

For a child to reach their full educational achievement a high level of school attendance is essential. We will consistently work towards a goal of 100% attendance for all children. Every opportunity will be used to convey to pupils and their parents or carers the importance of regular and punctual attendance.

School attendance is subject to various Education laws and this school attendance policy is written to reflect these laws and the guidance produced by the Department for Children, Families and Schools.

Each year the school will examine its attendance figures and set attendance/absence targets. These will reflect national targets.

The school will review its systems for improving attendance at regular intervals to ensure that it is achieving its set goals.

This policy will contain within it the procedures that the school will use to meet its attendance targets.

School Procedures

Any child who is absent from school at the morning or afternoon registration period must have their absence recorded as being authorised, unauthorised or as an approved educational activity [attendance out of school]. Only the headteacher or a member of staff acting on their behalf can authorise absence. If there is no known reason for the absence at registration, then the absence must be recorded in the first instance as unauthorised.

Lateness

Morning registration will take place at the start of school at **8.50am**. The registers will remain open for **15 minutes**, after which time the child will be allocated an unauthorised absence mark unless authorised circumstances have already been agreed with the Head Teacher. In cases, for example, where the absence at registration was for attending an early morning medical appointment, the appropriate authorized absence code will be entered.

The afternoon registration will be at 1 PM.
The registers will close at 1.15 PM.

Pupils arriving after the start of school but before the end of the registration period will be treated for statistical purposes, as present, but will be coded as late before registers close.

First Day Absence

Parents are expected to contact the school to inform the school of the absence. The secretary has an absence log which is completed as parents ring in. The secretary will text or phone the parents of any absent child if they have not contacted us by 9.30am. If no message or response is received, the child is marked absent and the register coded as 'No reason given'. Any unexplained absence by any pupil on the second day will be followed up by a phone call from the school. Absences without explanation will then be marked as 'Unauthorised'. If your child has any medical appointments, ie dentist, doctor or hospital, proof should be forwarded to the school and will be kept on record.

Third Day and Continuing Absence

If there has still been no contact from parents, the secretary will telephone again and enquire about the absence. If contact cannot be made, a standard letter is sent asking parents to contact the school. The school will endeavour to make contact over the period between 3 and 10 days. For vulnerable pupils the Headteacher will be immediately informed and they will endeavour to make contact via other known agencies.

Ten Day's Absence

Any pupil who is absent without an explanation for 10 consecutive days will be notified to the Local Authority, by submitting a referral to the Children's Services Attendance Team. The school will include details of the action that they have taken.

Frequent Absence

It is the responsibility of the Secretary and class teachers to be aware of and bring attention to, any emerging attendance concerns.

In cases where a pupil begins to develop a pattern of absences, the school will try to resolve the problem with the parent/s. If this is unsuccessful the school will refer to the School Health Adviser if the problem appears to be a medical one. In other cases the school will seek advice from the school's Attendance Improvement Officer (AIO). The Headteacher monitors at least half termly to agree any actions and reports on Attendance and absence to the Resources Committee and the Full Governing Body. The Headteacher will contact the Attendance Improvement officer with any emerging concerns that cannot be dealt with internally. The school operates the Fast Track Attendance Review system.

A Welcome Back

It is important that on return from an absence that all pupils are made to feel welcome. This should include ensuring that the pupil is helped to catch up on missed work and brought up to date on any information that has been passed to the other pupils.

Absence notes/ records of telephone calls

Notes or information received from parents explaining absence should be kept for the remainder of the academic year. If there are attendance concerns about the pupil, that may require further investigation, then the notes may need to be retained for a longer period. Reasons for absences are logged in the school management system.

Promoting attendance

The school will use opportunities as they arise to remind parents/carers, that it is their responsibility to ensure that their children receive their education. This will be achieved through regular assemblies and incentives such as certificates and good role models from adults within the school. Additional support will be sought from the Attendance Team whenever necessary to promote good attendance.

The school will reward pupils who have good or improving attendance. Those who have an attendance of 100% each term receive certificates. Those children exceeding the current school target at the end of the year will also receive certificates.

Regular reminders about punctuality and attendance are placed in the school newsletter. The Home/School agreement reinforces this responsibility.

The governing body has adopted the Fast Track Attendance Scheme in conjunction with the cluster schools. This includes a tiered system of letters to raise parent awareness when a child's attendance may be giving cause for concern (when it falls below 95% over a period of time).

Notification of Leave of Absence in term time

The Framingham Cluster have worked together to agree an approach in order that schools in the locality have a consistent approach to leave of absence requests and notifications. Parents/Carers are required to complete a notification form which makes the consequences of unauthorised absence clear.

The 'Education (pupil registration) (England) (amendment) regulations 2013', which came into force on 1 September 2013, removed references to family holidays and extended leave as well as the notional threshold of ten school days. The amendments made clear that head teachers may not grant any leave of absence during term time unless 'exceptional circumstances' exist. Following the principles of the NAHT we consider 'exceptional' as rare, significant, unavoidable and short.

Attendance concerns

We will continue work with Norfolk County Council who will issue penalty notices on behalf of schools for irregular attendance and unauthorised leave in term time until such time as the legislation or guidance from the government changes.

In light of the Isle of Wight judgement, from 16 May 2016, the criteria for the issue of a FPN will now be:

1. 15% or more unauthorised absence for reasons **other than** a term-time holiday within a six week period.
2. Where in a 12 week period, there are unauthorised absences bringing attendance below 90% and some or all of the absence may be attributed to an unauthorised holiday in term-time.

Requests for alternative school attendance arrangements

The Governing Body of Three Rivers Federation have considered the implications of Flexi Schooling and have decided that this is not an option that they will offer.

Attendance Targets

The school sets attendance targets each year. A system for analysing performance towards the targets has been established and the Headteacher is responsible for overseeing this work.

Our schools targets are:

2016/17: 97%

The registration system

Registers by law must be kept for at least 3 years.

Electronic back-ups may be made. These also need preserving for at least three years.

Register Security

Computer access is password protected. Monthly print outs are filed in a locked cupboard.

The School will use a computerised system for keeping the school attendance records.

Appendices

1 The Law

The Education Act 1996 Part 1, Section 7 states:

The parent of every child of compulsory school age shall cause him to receive efficient full-time education suitable-

- [a] To his age, ability and aptitude and
 - [b] To any special needs he may have.
- either by regular attendance at school or otherwise.

For educational purposes the term parent is used to include those that have parental responsibility and/or those that have the day to day care of the child.

The legislation that appertains to children who are of compulsory school age and are registered at school is contained within this Act.

Part V1 Section 444 contains the details of when an offence is committed if a child fails to attend school.

Register and Admission Roll keeping.

The legal requirements are found in:
The Education [Pupil Registration] (England) Regulations 2006

Categorisation of Absence

Any pupil who is on roll but not present in the school must be recorded within one of these categories.

1. Unauthorised Absence
2. Authorised Absence
3. Approved Educational Activity

1. Unauthorised absence

This is for those pupils where no reason has been provided, or whose absence is deemed to be without valid reason. This code will also be used for those children who arrive after registration has closed.

2. Authorised absence

This is for those pupils who are away from school for a reason that is deemed to be valid under the Education Act 1996.

3. Approved Educational Activity

This covers types of supervised educational activity undertaken off site but with the approval of the school.

Note Pupils recorded in this category are deemed to be present for attendance returns purposes.

This would include:

- Work experience placements
- Field trips and educational visits
- Sporting activities
- Link courses or approved education off site
- Most types of dual registration
